FLIGHT TO FREEDOM...

It is learnt that the Emir ordered the release of the eight Indians. The Navy veterans apparently faced charges of espionage, but neither the Qatari authorities nor New Delhi made the charges against them public. "The Government of India welcomes the release of eight Indian nationals working for the Dharma Global company who were detained in Qatar," the MEA said. "Seven out of the eight of them have returned to India. We appreciate the decision by the Emir of the State of Qatar to enable the release and home-coming of these nationals," it said in a brief statement.

In 2 months...
He added that the government is planning to start helicopter facilities from Indore to Ujjain and Omkarnagar before imposition of the Model Code of Conduct in view of the Lok Sabha elections. Stating that Simhashtha will be organised in 2028, Yadav said that to make the event successful, an extended planning to develop Ujjain and Indore will be prepared.

Comfortable win for...
As many as 43 Janata Dal (United) MLAs, 78 Bharatiya Janata Party MLAs, four Hindustani Awam Morcha legislators, an independent MLA and three RJD MLAs voted in favour of the motion. Deputy speaker Maheshwar Hazari of the JD (U) could not cast his vote as he was in the chair, while the UJ MLAs from Sursand, Dilip Rai, did not participate in the voting process in violation of the whip. The RJD MLAs who cross-voted in favour of the government are Chetan Anand, Neelam Devi and Pralhad Yadav. All the RJD MLAs were at the residence of party leader and former Deputy Chief Minister Tejashwi Yadav at 5, Deshmara Marg.

Industrial output...
In August 2023, inflation touched a high of 6.83 per cent. According to the data released by the National Statistical Office (NSO), retail inflation in the food basket was at 8.3 per cent in January 2024, down from 9.53 per cent in the preceding month. The Reserve Bank of India has been tasked by the government to ensure retail inflation remains at 4 per cent with a margin of 2 per cent on either side.

CONG LOSES ITS...
According to political observers, Chavan has not only the capacity to win elections but also the ability to wield power to spread the goodwill and win seats for his supporters. Given that Maharashtra may not be a cakewalk for the BJP in the general election, Chavan's entry can change the poll arithmetic in several districts in Maharashtra. Of course, Chavan's entry creates problems of plenty for the BJP which already has leaders of all hues vying for political space from CM Shinde to Devendra Fadnis to Ajit Pawar. So, in all probability

Chavan will be accommodated in the Rajya Sabha, the election to which is slated on February 27. The BJP is bending backwards to accommodate Chavan given his Adrish political baggage; the high-rise building meant for war widows and defence personnel had caused the party much embarrassment and Chavan had come within a whisker of being prosecuted.

MLAs wait in...
Earlier, BJP leaders had indicated that a similar rumour was imminent in the Congress. Their words are now proving true. The impending exit of Ashok Chavan will add a body blow to the Congress in Marathwada, given his clout in the region and in his stronghold, Nanded. Being a former CM, his was a weighty presence in the party. He commanded the trust of several MLAs. With the possibility of his joining the BJP, the names of leaders like Naseem Khan, Chandrakant Handore and MLA Visha Thackeray are also being mentioned as potential crossovers.

Sonia in RS...
For Priyanka Gandhi Vadra, whose entry in electoral politics has been speculated on for decades, this is seen as a safe seat. The constituency, a Congress bastion since 1950s, was first represented by her grandfather Feroze Gandhi. It was expected that Mr. Gandhi Vadra would contest in 2019 when she formally entered politics in January that year. Many had hoped for a face-off between her and Prime Minister Narendra Modi in Varanasi.

Talks fail, farmers...
In the meeting, the Centre is learnt to have agreed to withdraw the cases against the farmers registered during the 2020-21 agitation, sources said. However, the sources said, farmer leaders were adamant on a legal guarantee to minimum support price for crops, which is one of their key demands. The ministers -- Food and Consumer Affairs Minister Piyush Goyal and Agriculture Minister Anurag Thakur -- held the second round of talks with the farmer leaders at the Mahatma Gandhi State Institute of Public Administration in Sector 26.

Deep fakes, GenAI...
Celebrity impersonations, particularly targeting older demographics, have become widespread. These scams often originate on platforms like Facebook, tricking victims into a false sense of security, the report mentioned. "A troubling trend emerging is one where scammers routinely target older individuals, especially those who are widowed or suffer from financial loss," the report added. According to researchers, requests for money from newfound connections should sound immediate alarm bells. It's crucial to scrutinize photographs and videos that deliberately conceal background details, hindering online verification, they advised.
