

Trump faces revised 2020 poll charges

A revised and retouched set of charges was filed against President Donald Trump Tuesday by special counsel Jack Smith, providing a new twist in the 2020 election subversion case.

By trying to bring up his case after his initial indictment was nashed by the Supreme Court's immunity ruling, Smith signalled that he is determined to bring

the former president to justice.

The revised indictment has cast the portions of the case before the Supreme Court was not comfortable with and found mention in the Court's controversial immunity ruling and will now let the case move forward faster and smoother. The slimmed-down indictment now has 30 pages down from the original 45 pages. While the special counsel

did not drop any of the four counts against the former president in connection with the January 6, 2020 attempt to weaponize the Justice Department to help his reelection, the new indictment no longer mentions "co-conspirator 4" who was referenced nearly 30 times in the original case and was previously identified by the voters as Jeffrey Clark, a Trump appointee who embraced his false voter-fraud theories.

USA 24K PIOs to join Modi event

More than 24,000 members of the Indian diaspora have signed up to attend a mega community event, 'Modi & US Progress Together', that will be addressed by Prime Minister Narendra Modi in New York on September 22 at the Nassau Veterans Memorial Coliseum, which has a capacity of 15,000. The Indo-American Community of USA said registration for the event have come through 590 community organisations, all of whom have signed up as 'Welcome Partners', from across the US. While Indian Americans from at least 42 states are expected to attend, the response has been particularly strong from the tri-state area, it said. Modi is scheduled to address the UN General Assembly session on September 26.

USA Ist Capitol Hill rioter jailed

The first rioter to breach the US Capitol building during the January 6, 2021 riots was sentenced to nearly four-and-a-half years in prison on Tuesday. The Hill reported. In March, a federal jury delivered a guilty verdict against Michael Sparks, a 47-year-old individual from Kentucky, on six counts, including interfering with police and obstructing Congress from certifying the 2020 election results. The United States District Judge Timothy Kelly said that, for purposes of sentencing, he found obstructing the certification was Sparks's intent.

DHAKA Scribe's body found in lake

The body of a 32-year-old woman TV journalist from Bangladesh, identified as Sarah Rahanuma, was found floating in Hatirjheel Lake on Wednesday, according to media reports. Rahanuma was a newsroom editor at Gazi TV, a Bengali-language satellite and cable television channel owned by Gazi Group. Passersby took out her body and took it to the Dhaka Medical College Hospital (DMCH), where the doctor declared her dead. Police are probing cause of death. Her husband said she wanted to separate from him for some time.

YEMEN 25 killed in flash floods

At least 25 people were killed after flash floods hit Yemen's region of Al-Mahwit, a local health service reported on Wednesday. The flash floods were triggered by over 24 hours of heavy rain, that caused the collapse of three dams and swept away dozens of houses in the Mahalan district on Tuesday.
